Advocacy Tips!

- Learn about regulations and laws that support your desired goals and outcomes.
- Use words like advocate, due process, recourse -- state your position with the attitude that the desired end is already a given.
- Call yourself your child's advocate. The connotation is "lawyer" even though you are not.
- When you have achieved any desired outcome, thank you's can serve to motivate future cooperation and compliance. Everyone appreciates appreciation.
- Persistence! Call, call again, fax, write, follow-up with a call. The squeaky wheel gets the grease and the services.
- Get names!! People miraculously develop better manners if they think you can track them down.
- Everyone has a boss!! Start at the bottom and work your way up. If you are not getting satisfaction with someone, find out who their supervisor is; go all the way to the board of directors, president, etc., if need be.
- Everyone gets a paycheck. It can be very effective to find out where someone's funding comes from.
- There is never any excuse for rude treatment!! Let the rude person know you are aware of this basic right.
- Paper trails are critical. Document all names, incidents, what you were told, when, what you did, what they did.
- · Know your rights and entitlements, and be adamant in asking for them.
- Be very sparing when calling in favors; the "crying wolf" syndrome can take hold. If you ask for too many favors, you'll soon find closed ears. Use all possible resources before saying, "please do me a favor".
- If you want an organization or agency to help you, consider ways of helping that program. Volunteering in some way may encourage them to help you.
- Waiting lists are a reality put your child on the list. You've got to be in it to win it!
- The early bird catches the resource. If you think you are too early, too soon, jumping the gun, you are probably too late.

- Never put all your eggs in one basket; most of your eggs might be rotten.
 Brainstorm many options and back-up possibilities.
- · If all else fails, use the media!! Radio, television, newspapers, action reporters...
- Put the people who represent you and your families to work your elected officials such as your city councilman/woman, borough presidents, public advocate, your state assemblyman/woman, state senator, state governor, your United States congressman/woman, senators, the president. You never know!

Health Clinics Specializing in Children with Developmental Disabilities

Article 16 clinics: Facilities certified by OPWDD to provide habilitation services (long-term therapies) to persons with developmental disabilities. These services are ordered by a physician or other practitioner to reduce the effects of physical or mental disability, enabling the person to achieve maximum independence. Services include fitting, modification and training in the use of assistive devices to ameliorate the disability condition.

Article 28 clinics: Free standing or hospital based ambulatory care facilities licensed by the New York State Department of Health under Article 28 of the Public Health Law. Certain Article 28 facilities are explicitly designated by the State to service persons with developmental disabilities.

Health and Hospitals Corporation (HHC): A network of health facilities that will provide families with low cost and free health care regard less of immigration status. Some offer specific services for families of children with developmental disabilities.

Private Clinics: Institutions that are private run and have special needs clinics.

Finding Child Care

Your child has a right under the Americans with Disabilities Act to be given reasonable accommodations in all public accommodations that do not have a religious affiliation including early childhood programs, family and group care programs as well as after school centers. The fine for violating your child's rights could be \$55,000! The following agencies/programs can help you find appropriate child care for your infant, preschool or school age child in both special and mainstream settings.

Can My Child Receive Medication While in Child Care?

Sometimes children with disabilities require medication during the time they are in child care. By calling the above Child Care Resource and Referral (CCR&R) organizations, you can find out which child care providers have gone through Medication Administration Training (MAT Training) and are permitted to administer medication to your child. Call 888-469-5999 and ask to speak to a Health Consultant, NYS licensed RNs who are on staff at each of the CCR&R agencies. Having said this, please also be aware that refusing to administer medication might be considered a violation of the Americans with Disabilities Act! All child care providers should take the MAT training.

Need Help Paying for Child Care?

The Administration for Children's Services (ACS) determines a family's eligibility for subsidized child care. If you are working, attending school or a job training program you may be eligible for subsidized child care.

Call 311 or log onto www.nvc.gov/html/acs to request an application.

Families can also use the Child Care Eligibility Wizard on the ACS website at www.nyc.gov/html/acs/chidcare_eligibility/wizard.html to determine if they qualify for a subsidy.

Homecare

If you have Medicaid and are in need of assistance in your home, you might qualify for homecare.

Homecare is not a babysitting service. If you need temporary child care, other resources such as friends, relatives, or respite care should be used.

Home Care Services are a crisis intervention service when you are unable to care for your family's basic needs. They are training services to help you learn how to manage your household more effectively, not to manage your responsibilities.

How can I apply for Home Care Services?

Children in receipt of Medicaid who are enrolled in a managed care plan should access home care services from their managed care plan. Discuss with the child's primary care physician the need for this service. The plan will assess eligibility for home care, as well as the number of hours needed.

Children who are exempt from managed care enrollment and who receive fee-forservice Medicaid should request home care through their local CASA office. To find your local CASA office call NYC Homecare: 212-676-6800. Your physician must sign a Medical Request for Home Care Services, **(M11Q form)** verifying that you or your child are medically eligible for these services. The doctor then forwards the application to the ACS Family Home Care Intake Division. Once they receive the application, Family Home Care will forward the request to your local field office, who will contact you about visiting your home to determine your needs.

Note: If you or your child has AIDS or is HIV+, the request for Home Care should be forwarded directly to the Division of AIDS Services (DAS). For more information, please call DAS at (212) 971-0626.

1) Consumer Directed Personal Assistance Program (CD-PAP): If your child has Medicaid and you have someone whom you trust to care for your child, Medicaid might pay that person. Contact your local Community Alternative Systems Agency (CASA) Office: To find your local CASA office you can contact NYC Homecare: 212-676-6800. You will need a doctor to fill out a form called an M11Q. Homecare can send it to you. If approved, you can choose the person to care for your child and Medicaid might pay that person.

Is it a legal eviction? Only the City Marshall can evict you, not the landlord. Were the eviction papers properly served to you? (The landlord must hand deliver it, post it on the premises, or send it certified mail to ensure the tenant receives it but is must be from the City Marshall)

If it is a legal eviction, did you go to housing court?: That is where you must go if it is a legal eviction to explain your side of the story. You must go within 5 business days after receiving a legal eviction to explain your side of the story (fill out an **Order To Show Cause**)

Why are you being evicted?: Didn't pay your rent? Landlord selling the building? Landlord wants to put his family in your apartment? Know your rights! Is this a **Non-Payment Eviction** (you have not pay the rent) or a **Holdover Eviction** (court action in which your landlord is demanding possession of the apartment and wants to evict you. A Holdover proceeding is brought against a tenant whether or not the tenant has paid rent).

Who can help me?

Legal Aid-If you are on public assistance and have a child you may be able to qualify for the Family Eviction Prevention Supplement. **Only if you have a pending non-payment eviction in housing court.** This program helps pay back rent and subsidize future rent.

Laws that Protect the Rights of People with Disabilities and Their Families

The Americans with Disabilities Act

Children and adults with disabilities have a right to be given reasonable accommodations in public and private programs that do not have a religious affiliation. from this law. \$55,000 fine if you file a lawsuit with the U.S. Department of Justice, Office of Civil Rights and win your case.

The only valid reason a program can deny your family member access is if they can prove it would be an undo financial hardship, it would fundamentally change the nature of the program or even with accommodations, including your family member would be a dangerous situation. Nobody has a crystal ball and get tell you in advance that your child is a danger!

New York State Human Rights Law

This NYS law protects people from discrimination because of race, creed, color, national origin, sexual orientation, military status, sex, age, marital status, domestic violence victim status, disability, predisposing genetic characteristics or prior arrest or conviction record, or if you believe you have been retaliated against for opposing unlawful discriminatory practices, you may be able to file a complaint with the State Division of Human Rights. The New York State Human Rights Law forbids discrimination in employment, apprenticeship and training; purchase and rental of housing and commercial space; places of public accommodation, resort and amusement; nonsectarian; tax-exempt educational institutions; and all credit transactions.

How Do I Qualify for Services?

The People First Waiver

Help!: I need respite, case management, recreation, parent training, medical services, support, job training for my teenager, and so much more!! I want to make sure he/she has as rich and full a life as possible. How do I begin this journey?

Right now, regardless of your family income, it is possible to obtain Medicaid through a system called **Medicaid Waiver**. If you have the appropriate documentation that can prove your child's level of need: that your child has an intellectual disability resulting in functional limitations, you might qualify. Your DDSO can help link you with places that will test your child and providers who will help you enroll in the program. In order to obtain Medicaid Waiver, you will need to attend a **"Front Door"** orientation meeting. You can contact your DDRO and they will give you dates for these sessions.

The whole system is transitioning into a new waiver called the 1915 B&C Waiver (People First Waiver). Don't worry about what it is called-just know that this new transition will allow you to link with a network of experienced providers called a DISCO: Developmental Disabilities Individual Support and Care Coordination Organization. Based on the results of a universal assessment tool, it will be determined how much funding will be allotted for your child's needs: medical, social, vocational etc. It won't be chiseled in stone as we all know life throws us some curve balls. Should a crisis arise, that budget can always be re-evaluated based upon new needs. It will however be capitated (limited).

You will be receive **Care Coordination** instead of a Medicaid Service Coordinator. This will be a team of professionals who will work together with you to make sure your child's needs are being met. You can also **dream** and try to make those dreams come true. If you feel that your child's needs can best be served in a mainstream after school program with a shadow teacher, this new Waiver will hopefully allow for such cost effective creative options. Creative housing options, work options and on and on!

Your child might need supportive services as well as your family, through all the transitions that life brings. This new People First Waiver seeks to help you with this in a way that includes your child, teenager, adult in the community to the greatest extent possible.

Under the old system, 91% of OPWDD funding was going toward supervised housing and Day Treatment programs. Under this new waiver, the individual with an intellectual disability and the family, together with the Care Coordination team can visualize and realize more person-centered cost effective options. This will all take team work, critical and creative thinking about what is best for your family member with an intellectual disability and some good dreaming!

Paying Utility Bills

Con Edison

Low-Income Rate Program.

Provides individuals on Public Assistance, Supplemental Security Income (SSI), or the Home Energy Assistance Program (HEAP) with a monthly \$6 reduction in their basic electric service charge. Customers are still obligated to pay the regular market supply price per kilowatt of energy used. Most eligible customers are automatically enrolled in this program; those who are not should fax or mail a copy of their grant letter, indicating their PA, SSI, or HEAP status, to the New York Con Edison offices: Attention: PA Central, Consolidated Edison, 4 Irving Place, Room 9NE, New York, NY 10003, Fax: 212-780-6320. Low-Income Gas Plan.

Provides customers who are on Public Assistance (PA), Supplemental Security Income (SSI), or the Home Energy Assistance Program (HEAP) with a 25% reduced gas delivery rate. Customers who use gas energy for purposes other than heating their homes (such as for cooking or hot water) will be required to pay market price over a certain level; call for more information on pricing. Energy Share.

Provides one-time grants of up to \$200 to Con Edison customers who need assistance meeting monthly electricity bill payments. Customers must be HEAP eligible (visit the **HEAP Web site** for eligibility information), submit a copy of a disconnection notice, and have made at least one payment to Con Edison prior to receiving a disconnection notice.
