#### 3. Review of Budget Amendments

Joe Williams informed the council that the changes amended to the budget were approved. No gift certificates can be purchased with leftover monies. All monies must be used for this year.

## 4. Status of Resolutions

Joe and Jackie are currently working on resolutions to be sent to Albany for I-pads to be placed back on purchase list for council use. The Klein Tablet might be the only foreseeable barrier to this resolution not being passed. The Klein Tablet is currently being adapted into the curriculum outside of NYC. The idea of purchasing food ahead of time for summer meetings was suggested.

#### 5. Purchase of Computer Equipment to be used by The Council President

The DOE has changed the availability of purchasing computer equipment thru outside sources, they must now be purchased from the DOE vendor subject to approval upon selection. They allow up to \$3000.00. The DOE does not allow for purchase of I-pads under any circumstance. I-pads are not known to last longer than 2-3 years. An idea was proposed to purchase a camera/video camera for the purpose of taking pictures of invited guest that attend our meetings versus using our cell phones.

#### 6. Privacy of Student Information within the DOE

DOE gave Klein's company access to student information as well as Microsoft making our students vulnerable to Identity Theft. It gives companies availability to information as sensitive as Social Security numbers. Parents are considering class actions suits to prohibit the DOE from distributing student's information without parental consent. A court order can stop this.
