

RESOLUTION TO APPROVE THE RECOMMENDATION TO RENAME THE DISTRICT 75 SCHOOL P396K FROM RAMÓN E BETANCES TO THE SID MILLER SCHOOL

THE CITYWIDE EDUCATION COUNCIL FOR DISTRICT 75, DURING IT'S BUSINESS MEETING OF JUNE 6, 2018, UNANIMOUSLY APPROVED RESOLUTION CECD75 (17-19)(01)(18.06.20) AND RATIFIED IT AT ITS CALENDAR MEETING ON WEDNESDAY, JUNE 20, 2018, AT COURT SQUARE CONFERENCE CENTER, 45-18 COURT SQUARE, LONG ISLAND CITY, NY 11101.

THE RESOLUTION READS AS FOLLOWS:

Whereas, the Principal of a District 75 (D75) School in Brooklyn, P396K has requested from the Citywide Education Council for District 75(CECD75) the approval for recommendation to rename said school from Ramón E. Betances to The Sid Miller School

Whereas, the Principal of the District 75 school P396K has submitted to the Citywide Education Council for District 75 all the documentation and application(s) required under Chancellors Regulations A-860 (CR A-860)

Whereas, the members of the Citywide Education Council for District 75 have reviewed said documentation and application(s) and have found it in compliance with Chancellors Regulation A-860, §I.D; §§I.F.3, F.4, F.8 and §I.H)

Whereas, the reasons presented to the Citywide Education Council for District 75 for the renaming of the D75 school, P396K, from Ramón E. Betances to The Sid Miller School, are valid and reasonable and further enhances the mission and goals of the education of District 75 students

The Citywide Education Council for District 75 hereby puts forth the following:

- I. **Let it be resolved that:** the Citywide Education Council for District 75 approves the recommendation to rename the District 75 school, P396K, located in Brooklyn, from Ramon E. Betances to the Sid Miller School
- II. **Let it be resolved that:** the Citywide Education Council for District 75 formally requests the District 75 Superintendent to submit the documentation for the proposed name change along with the Citywide Education Council for District 75 resolution in support of the above name change, to the Family and Community Engagement (FACE) for review and approval by the Chancellor or his designee.


