- ♦ He provided brief tips on IEP Meetings as well as informing parents IEP Meetings should not happen without the parent being present. Also parents are allowed to request and have representation at the meetings.

- ♦ Arts Dept.: To have outings to bring the arts, and families can experience theater, working to get tickets.
- ♦ Visions Dept.: partnered up with District 75 for the blind
- Literacy Dept.: trained parent coordinators other forms of communication without offending anyone.
- ♦ The Fathers Initiative is a support group and vehicle for getting fathers of District 75 involved in their child's education and school community. What does it mean to be a father who is involved, supports and contributes to the school community as well as their daily educational needs?
- At the end of the year, a celebration is held in honor of the fathers.
