The council members are focused on working hard for the improvement of our children's education.

There are many concerns we will need to continue to address such as:

- Co-locations
- Lack of Space
- Related Services
- Charter Schools
- DOE Transparency and Notification in a timely manner.
- Busing

Our council has represented parents within District 75 first as the Citywide Council on Special Education and when the laws changed July 1, 2010 the parents of District 75 wrote letters and signed petitions to ensure that their children had a unified voice that would continue to represent District 75.

We have fought for the parents when it came to their child's IEP; Busing, supported Principals, the superintendent and addresses any other concerns that have come to our attention.

- 369 at 133 located in Park Slope, BKLYN
- 94M at 281 and 51, located in Manhattan- East and West Side
- 277 at HS 404 and key 78, located in Long Island City
- Six new additional sites located in existing buildings: 771 at P66 located in East NY
