


# ADVOCATING FOR BETTER BUSING IN DISTRICT 75: A PARENT'S GUIDE

# FAIR BUSING

### WHY IT MATTERS

The Current Situation: Lack of drivers, lack of paraprofessionals, delays, safety and sensitivity training.

Impact on Our Children: Many of our children thrive on routine, and transportation disruptions—whether it's delays, missed pickups, or changes to routes—create unnecessary stress and behavioral challenges for them; leading to exhaustion and reduced ability to focus in the classroom.

Why Parents' Voices Matter: Your voice as a parent matters because it brings urgency, expertise, and accountability to an issue that directly affects your child's future. By speaking up and advocating for change, you are not only fighting for your child but also for the rights of every District 75 student to receive the safe, reliable transportation they deserve.



# KNOW YOUR RIGHTS

Key Laws & Policies:

### Individuals with Disabilities Education Act (IDEA):

- Mandates that students with disabilities receive a Free Appropriate Public Education (FAPE).
- Requires related services, such as transportation, to be provided when necessary for accessing education.

### Section 504 of the Rehabilitation Act:

Prohibits discrimination based on disability in federally funded programs, including school transportation.

### Americans with Disabilities Act (ADA):

• Ensures that public transportation is accessible to individuals with disabilities.

### **New York State Education Law:**


- Mandates transportation services for students with disabilities as part of their Individualized Education Program (IEP).
- NYC Department of Education Policies:
- Guarantees specialized transportation (e.g., door-to-door service) for eligible students in District 75.
- Provides protocols for parents to report and resolve transportation issues.

### **Impact on Students and Families**

- Consistency is Key: Many District 75 students rely on routine, and transportation delays or disruptions can cause significant anxiety and behavioral challenges.
- Long Commutes: Some students endure hours-long rides, leading to fatigue, reduced classroom engagement, and health concerns.
- Safety Concerns: Reports of unsupervised buses, lack of proper safety measures, and insufficiently trained staff are alarming.

#### **Emotional Toll**

- Stress on Families: Parents are left juggling work commitments and personal responsibilities due to unreliable transportation.
- Impact on Students: Missing school or arriving late disrupts learning and social development, especially for students with specialized needs.

### **Systemic Issues**

- Lack of Accountability: Current oversight of transportation providers is inadequate, allowing repeated failures without consequences.
- Communication Breakdowns: Parents often lack timely updates on delays or route changes, leaving them frustrated and uninformed.
- Inadequate Infrastructure: Insufficient resources and outdated technology hinder the efficiency of the transportation system.

### **Legal and Policy Violations**

- Violation of IDEA: The Individuals with Disabilities Education Act (IDEA) guarantees transportation as a related service, essential for access to education. Delays and missed pickups violate this right.
- Unmet IEP Requirements: Many Individualized Education Programs (IEPs) specify door-to-door transportation, which isn't always provided.

### **Solutions and Demands**

- Improved Funding: Advocate for increased resources to upgrade buses, train staff, and implement advanced routing technologies.
- Stronger Oversight: Enforce stricter accountability measures for transportation providers to ensure quality service.
- Transparent Communication: Develop real-time tracking and notification systems to keep parents informed about delays and changes.
- Stakeholder Engagement: Include parents, educators, and advocates in transportation policy discussions.


